

**FACTS****WHAT DOES FAST FORWARD INSURANCE, INC., DBA FAST FORWARD INSURANCE SERVICES DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives the consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- ◆ Social Security Number and information you provide us on applications or other forms
- ◆ Payment history, transaction history we receive from you and others, and loss history
- ◆ Medical information and insurance claims history

When you are *no longer* our customer, we continue to share information as described in this notice.

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Fast Forward Insurance, Inc. chooses to share; and whether you can limit this sharing.

What we do	
<b>How does Fast Forward Insurance Services protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We limit employee access to your information to only when they need it to do their work and require companies we work with to safeguard your information.
<b>How does Fast Forward Insurance Services collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>◆ Apply for insurance or pay insurance premiums</li> <li>◆ File and insurance claim or show your driver's license</li> <li>◆ Provide your mortgage information or give us your contact information</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>◆ Sharing for affiliates' everyday business purposes—information about your credit worthiness</li> <li>◆ Affiliates from using your information to market to you</li> <li>◆ Sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing, See below for more on your rights under state law.
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.

Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>◆ <i>Our affiliates include non-financial companies such as Mortgage Works, LLC, and financial companies such as Mountain West Financial, Inc.</i></li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li>◆ <i>Fast Forward Insurance Services does not share with nonaffiliates so they can market you.</i></li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>◆ <i>Our joint marketing partners include categories of companies such as insurance companies, mortgage companies, and real estate companies.</i></li> </ul>
